KnightBeam LED warrants that its CRUISADER-branded automotive lamps (referred herein as "Product") shall be free of defects in material and workmanship and shall meet passenger automobile and light truck light bulb performance standards for:

12 months (1) year from the date of purchase (referred to as the "Warranty Period")

This limited warranty ("Warranty") is solely limited to the replacement of the failed Product, as determined and/or confirmed by KnightBeamLED in its sole discretion.

This Warranty does not include the cost of labor for installation, removal or re-installation of a replacement Product.

This Warranty is limited to the original consumer and vehicle, and is not transferable to subsequent owners of the Product or to subsequent vehicles on which the Product has been installed.

This Warranty assumes that installation of the Product was done in accordance with all applicable instructions and industry standards.

This Warranty specifically excludes any and all damage or loss caused by faulty or improper Product installation.

This Warranty includes criteria for Lumen loss that exceeds 30% from original design intent herein known as the L_{70} threshold value.

This Warranty specifically excludes normal wear and tear; failures caused by misuse; use in racing; marine; use in under water applications; aircraft or heavy-duty/commercial/fleet applications; unauthorized Product modifications; neglect; abuse; accidents; or other improper uses of the Product.

This Warranty is the only express warranty that applies to the Product and sets forth all of the obligations and responsibilities of KnightBeam LED. All applicable implied warranties, if any, are limited to the terms, conditions, and duration of this express Warranty.

All other warranties, express or implied, are specifically disclaimed including but not limited to any implied warranties of merchantability or fitness for a particular purpose.

KnightBeam LED and its parent company shall not be responsible or liable for any amount of damage beyond the replacement of (or reimbursement for the cost of) the Product.

Incidental, consequential, special, or punitive damages (including lost profits, vehicle damage, property damage, bodily injury, death, mental anguish, emotional distress) are specifically excluded from coverage under this Warranty.

State Law Rights: This Warranty gives you the buyer specific legal rights, and you may also have other rights which vary from state to state. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

To qualify for Warranty coverage, you must do the following:

• Promptly after purchase, go to KnightBeam.com and fill out the warranty registration online indicating the vehicle make, model, model year, and date the product was installed; if not completed, we will to the best of our abilities attempt to verify your warranty eligibility and start date based on our records.

- If the Product fails during the Warranty Period, go to KnightBeam.com and file a claim.
 - o If requested, please return the Product, we may use it for continual engineering improvement activities.

If your claim is approved, a replacement Product will be provided to you free of charge. As an alternative to replacing the Product, KnightBeam LED may also elect to reimburse you for the cost of the Product, in its sole discretion.

This Warranty is only available in North America and may be amended or terminated, without notice and in KnightBeam LED's sole discretion.
